### 1. Instructions if you are transferring units to an existing investor.

- enter the transferee's investor number and investor name in Section 3, as they appear on their latest periodic statement or transaction statement
- both you and the transferee need to sign this form as per the 'Signing instructions' in Section 5.

### 2. Instructions if you are transferring units to a new investor.

- enter your investor number and investor name as they appear on your latest periodic or transaction statement

- arrange for copies of their identification documents to be certified.
